4. FIRST-AID MEASURES

Inhalation

If inhaled, remove affected person from contaminated area. Apply artificial respiration if not breathing. Seek medical attention.

Ingestion

Skin

Precautions in connection with Fire

Fire fighters should wear Self-Contained Breathing Apparatus (SCBA) operated in positive pressure mode and full protective clothing to prevent exposure to vapours or fumes. Water spray may be used to cool down heat-exposed containers. Fight fire from safe location. This product should be prevented from entering drains and watercourses.

6. ACCIDENTAL RELEASE MEASURES

Emergency Procedures

Wear appropriate personal protective equipment and clothing to minimise exposure. Increase ventilation. If possible contain the spill. As a water based product, if spilt on electrical equipment the product will cause short-circuits. Place inert absorbent material onto spillage. Collect the material and place into a suitable labelled container. Do not dilute material but contain. Dispose of waste according to the applicable local and national regulations. If contamination of sewers or waterways occurs inform the local water and waste management authorities in accordance with local regulations.

7. HANDLING AND STORAGE

Precautions for Safe Handling

Corrosive liquid. Attacks skin and eyes. Causes burns. Wear suitable protective clothing, gloves and eye/face protection when mixing and using. Avoid contact with eyes. Avoid contact with skin. Use in designated areas with adequate ventilation. Avoid breathing in vapours, mist or fumes. Keep containers closed when not in use. Ensure a high level of personal hygiene is maintained when using this product, that is, always wash hands after handling, and before eating, drinking, smoking or using the toilet facilities.

Conditions for safe storage, including any incompatibilities

Store in a cool dry well-ventilated area. Protect from freezing. Store away from oxidising agents and bases. Keep containers closed when not in use, securely sealed and protected against physical damage. Inspect regularly for deficiencies such as damage or leaks. Provide a catch-tank in a bunded area. Store in original packages as approved by manufacturer. For information on the design of the storeroom, reference should be made to Australian Standard AS 3780-2008: The storage and handling of corrosive substances. Reference should also be made to all State and Federal regulations.

Appropriate Engineering Controls

Respiratory Protection

10. STABILITY AND REACTIVITY
